Why take part?



What is Children of the 2020s?

Children of the 2020s is a national study of around 8,500 children born in England at the start of the 2020s. By following children and their families over time, the study aims to understand how their experiences and circumstances affect early development. We surveyed families when children were around 9 to 12 months and will be following them up over time when their children are 2, 3, 4 and 5 years old. This is an important time for us to understand how children are developing, and the factors that help them, eventually, to be ready for school.

Who is running this study?

The study was commissioned by the Department for Education, is led by University College London (UCL), and the independent research organisation Ipsos is helping collect the data. Further information about Ipsos can be found at: www.ipsos.com/en-uk
