



Take part in the Children of the 2020s study: Age 3 survey

Dear

We are writing to invite you and your child(ren) to take part in the Children of the 2020s study: Age 3 survey. Thank you for taking part in the study so far! Your participation has helped us learn a huge amount about young children and their families in England. You may have even seen the study in the press! The Age 9-month survey report received media coverage by The Times, the Independent, and the Evening Standard, amongst others.

What does taking part in the Age 3 survey involve?

A trained Ipsos interviewer carrying photo ID will arrange to visit you and your 3-year-old(s) at your home so that you can take part in some research activities. These are:

- A short questionnaire about you and your child(ren)'s development and family life
- Some fun research activities with your 3-year-old(s) that are designed to measure their learning and development (see children2020s.ipsos.com)
- A 5-minute video recording of you and your child reading a book and playing with some toys

The visit will take around 70 minutes. One parent/guardian and your 3-year-old(s) will need to be present.

As a thank you for taking part in the survey, we will give you a £____ e-voucher that you can use at a range of retailers. Information on how to redeem your voucher will be sent by email.

What happens next?

In the coming days, an Ipsos interviewer will call at your address, or phone you, to arrange a convenient day and time to complete the research activities with you and your 3-year-old(s) in your home. They'll be happy to answer any questions you may have. If they call at your address and you're out or it's not convenient, the interviewer will come back at a better time. If you would prefer to contact your interviewer before they contact you, please text or phone them using their number included on back of the leaflet.

Taking part is completely voluntary, and any information you give us will be protected by law, treated as confidential, and used only for research purposes. We hope you decide to take part in this important research and that you enjoy the visit.

What is Children of the 2020s?

Children of the 2020s is a national study of around 8,500 children born in England at the start of the 2020s. The study aims to understand how their experiences and circumstances affect early development. We surveyed families when children were around 9 months and 2 years and will be following them up over time when the children are 3, 4 and 5 years old. This is an important time for us to understand how children are developing, and the factors that help them, eventually, to be ready for school.

Who is running this study?

The study is commissioned by the Department for Education, is led by University College London (UCL), and the independent research organisation, Ipsos, is helping collect the data. How do I get my voucher and where can I use it?

Once you have completed the survey and confirmed you accept your voucher, you will be asked for your email address. Your privacy

The information you give us will be held securely and will be treated in strict confidence in accordance with the Data Protection Act 2018 and UK General Data Protection Regulation. Data from the Children of the 2020s study will be anonymised and made available securely by the Department for Education to suitably qualified researchers conducting legitimate research on children's development in the public interest. Personal data identifying you or your child will never be given to these researchers. This information will be used solely for research purposes. Any information you provide during this research will NOT be used for marketing, nor will we sell or pass on your information to any third party. Do I have to take part?

Your participation is entirely voluntary, and you can withdraw your consent to take part at any time without having to give a reason. You can choose not to do this survey and still be part of the study. To withdraw please let us know using the contact information below. If you withdraw from the study any data already collected will continue to be used unless you explicitly request that we delete it. If you request that we delete any personal identifiable information (such as name and contact details), we will delete this and stop collecting and linking data you provided us. If you also wish to have your anonymised survey data (your answers to the survey questions) deleted and not deposited, please make this request within 6 months of taking part in the survey. After that date it will not be possible to remove your anonymised data from the study.
